

City of Tea
Regular Meeting
February 17, 2026

The regular meeting of the Tea City Council was held at Tea City Hall on February 17 2026 at 6:00 pm.

Mayor Casey Voelker called the meeting to order at 6:00 pm with the following members present: Terry Woessner, James Erck, Joe Weis and Lynn DeYoung. Also present: City Administrator Justin Weiland, Community Development Director Albert Schmit and Finance Officer Dawn Murphy. Absent: Councilmembers Aaron Otten and Ruby Zuraff.

AGENDA. MOTION 26-18. MOTION by Erck, seconded by Woessner to approve the February 17, 2026 Agenda. All members voted AYE.

CONSENT AGENDA. MOTION 26-19. MOTION by Woessner, seconded by Chapman to approve the following consent agenda items:

PUBLIC COMMENT. There were no public comments.

PUBLIC HEARING REGARDING PROPOSED ISSUANCE OF TAX-EXEMPT REFUNDING BONDS. City Attorney Todd Meierhenry of Meierhenry Sargent spoke to the Council on acting as a Conduit Bond Financier for the University of Sioux Falls. 501(c)(3) Conduit Bonds allow nonprofit institutions to borrow at tax-exempt interest rates. Federal law requires a governmental entity to issue the bonds. When the governmental entity does not provide funding or guarantee repayment, it acts solely as a conduit issuer. The bonds are not a debt of the City; does not pledge taxes or City Revenues; and repayment comes solely from the University of Sioux Falls. The City's role is limited to procedural approvals, document execution and put the outstanding balance of the bonds in a foot note on their audit. **RESOLUTION 26-02-03. MOTION 26-20. MOTION** by DeYoung, seconded by Woessner to approve the following Resolution. All members voted AYE. **A RESOLUTION AUTHORIZING THE ISSUANCE OF REFUNDING REVENUE BONDS TO REFUND CERTAIN OUTSTANDING BONDS PREVIOUSLY ISSUED FOR THE BENEFIT OF THE UNIVERSITY OF SIOUX FALLS; APPROVING THE FORM OF AND AUTHORIZING THE EXECUTION OF CERTAIN DOCUMENTS; AND AUTHORIZING CERTAIN OTHER ACTIONS RELATED THERETO.**

WHEREAS, City of Tea, South Dakota (the "City"), is authorized pursuant to the laws of the State of South Dakota, including SDCL Chapter 9-54, §§ 6-8B-30 through 6-8B-52, and other applicable provisions of state law, to issue conduit revenue obligations for the purpose of refunding outstanding obligations previously issued for charitable, educational, or otherwise tax-exempt purposes; and

WHEREAS, the South Dakota Health and Educational Facilities Authority (the "Authority") previously issued its Revenue Bonds (University of Sioux Falls Issue), Series 2020, in the original aggregate principal amount of \$18,000,000 (the "Series 2020 Bonds"), pursuant to a Bond Trust Indenture dated as of February 1, 2020, between the Authority and U.S. Bank National Association, as trustee (the "Indenture"); and

WHEREAS, the proceeds of the Series 2020 Bonds were loaned to the University of Sioux Falls, a South Dakota nonprofit corporation described in Section 501(c)(3) of the Internal Revenue Code, to (i) refund the Authority's Revenue Bonds (University of Sioux Falls Issue), Series 2010, originally issued in the amount of \$11,157,000, (ii) finance and refinance educational facilities of the University of Sioux Falls, and (iii) pay certain costs of issuance; and

WHEREAS, the University of Sioux Falls has requested that the City serve as a conduit issuer of refunding revenue bonds (the "Refunding Bonds") for the purpose of refunding all or a portion of the outstanding Series 2020 Bonds; and

WHEREAS, the City is permitted to issue such Refunding Bonds, provided the requirements of Section 147(f) of the Internal Revenue Code are satisfied, including the holding of a public hearing following reasonable public notice and the approval of this governing body; and

WHEREAS, notice of a public hearing was duly published, and on February 17, 2026, between 6:00 p.m. and the adjournment of the meeting, the City conducted a public hearing regarding the issuance of the Refunding Bonds; and

WHEREAS, the Refunding Bonds will be special, limited obligations of the City, payable solely from revenues derived from the University of Sioux Falls pursuant to financing documents, and will not constitute a debt or obligation of the City, the State of South Dakota, or any political subdivision thereof, nor will the credit or taxing power of the City, the State, or any political subdivision be pledged; and

WHEREAS, if issued, the Refunding Bonds are intended to be qualified 501(c)(3) bonds under Section 145 of the Internal Revenue Code.

NOW, THEREFORE, BE IT RESOLVED by the City Council of City of Tea, South Dakota, as follows:

Section 1. Approval of Refunding Bonds. The City hereby approves the issuance of the Refunding Bonds, in one or more series, in a principal amount not to exceed \$9,900,000, for the purpose of refunding the Series 2020 Bonds described in the Indenture and financing related costs of issuance.

Section 2. No City Liability. The Refunding Bonds shall be special, limited obligations, payable solely from revenues pledged for their repayment. Neither the City, the State of South Dakota, nor any political subdivision shall be obligated to pay the Refunding Bonds, and neither the City's nor the State's taxing power shall be pledged.

Section 3. Approval of Documents. The City Council hereby approves the forms of the following documents, with such changes as deemed necessary and appropriate by Meierhenry Sargent, LLP ("Bond Counsel") and City officials:

- (a) A Bond Purchase Agreement or Placement Agreement;
- (b) A Loan Agreement with the University of Sioux Falls;
- (c) The form of the Bond;
- (d) The Tax Agreement/ Tax Regulatory Agreement; and
- (e) Such other documents as may be required to issue and secure the Refunding Bonds.

Section 4. Execution and Delivery. The Mayor, Finance Officer, and other appropriate City officials are authorized and directed to execute the documents approved in Section 3 and to take all steps necessary to effectuate the issuance, sale, and delivery of the Refunding Bonds.

Section 5. TEFRA Approval. The City Council hereby gives approval for purposes of Section 147(f) of the Internal Revenue Code and confirms the public hearing held February 17, 2026 in the City Council room.

Section 6. Effective Date. This Resolution shall take effect immediately upon passage.

MOTION** by Erck seconded by Chapman to set the second reading of Ordinance 331 for March 2, 2026. All members voted AYE.

ORDINANCE 335. The Council held the first reading of Ordinance 335. An Ordinance Amending Chapters 3, 4, 5, 6, 12 and 19 of the Zoning Regulations of the City of Tea, Lincoln County South Dakota. The full ordinance and explanation of changes can be found on the City's website and is on file at City Hall. **MOTION 26-22. MOTION** by Erck seconded by Chapman to set the second reading of Ordinance 335 for March 2, 2026. All members voted AYE.

TIF DISTRICT #2 TIF PLAN AMENDMENT #1. A TIF plan amendment may occur within five years of the adoption of the establishment of the district. Weiland worked with Colliers Securities, Tobin Morris to prepare an amendment to the TIF District #2 TIF Plan. The City has analyzed TIF #2 to determine that an amendment is justified. The amendment creates additional TIF Funds available for the completion of necessary public infrastructure that will serve the TIF District. **MOTION 26-23. MOTION** by DeYoung, seconded by Woessner to approve and adopt the following resolution. All members voted AYE. **RESOLUTION 26-02-02. A RESOLUTION OF THE CITY OF TEA CITY COUNCIL APPROVING AMENDMENT #1 TO THE TAX INCREMENT FINANCE DISTRICT #2 PROJECT PLAN.**

WHEREAS, the City of Tea City Council established Tax Increment Finance District #2 pursuant to SDCL Chapter 11-9; and WHEREAS, Amendment #1 increases the maximum eligible project costs to \$6,999,247, consistent with SDCL § 11-9-23; and WHEREAS, the Planning Commission has reviewed and recommended approval of Amendment #1;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Tea, South Dakota that:

1. The City Council hereby finds and determines that:

- (a) The original Tax Increment Finance District #2 Project Plan, approved in September 2021, authorized eligible project costs in the amount of \$5,184,628.
- (b) Amendment #1 to the Project Plan increases the maximum authorized eligible project costs to \$6,999,247.
- (c) The increase in authorized project costs equals \$1,814,619, which represents an increase of thirty-five percent (35%) of the original approved project cost amount.
- (d) Pursuant to SDCL § 11-9-23, because the increase in project costs does not exceed thirty-five percent (35%) of the amount approved in the original Project Plan, and because the additional project costs will be incurred within the time

period specified in the original Project Plan, no redetermination of the tax increment base by the South Dakota Department of Revenue is required.

(e) The amended Project Plan therefore remains valid and compliant with SDCL Chapter 11-9.

2. Amendment #1 to the Tax Increment Finance District #2 Project Plan is hereby approved.

3. The amended Project Plan is adopted pursuant to SDCL Chapter 11-9.
