**SECOND READING OF ORDINANCE 334.** Councilmember Chapman recused himself from discussion and voting on Ordinance 334 due to a conflict of interest. The Council held the second reading of Ordinance 334. **MOTION 26-16. MOTION** by Erck, seconded by Otten to approve and adopt Ordinance 334, An Ordinance of the City of Tea, SD, Rezoning Property Located at 1510 East First Street From the R-1 Single Family Residential District to the GB General Business District, No. 25-03 and Amending the Official Zoning Map of the City of Tea. Members Zuraff, Otten, Woessner, Erck and DeYoung voted AYE. Councilmember Chapman abstained/recused himself. Motion carried. The ordinance will be published separately.

**TEA TAX INCREMENT FINANCE DISTRICT #2.** Weiland went through the proposed TIF District #2 Plan Amendment. The amendment increases the plan by 35% or an increase of \$1,814,619. A formal resolution will be adopted at a future meeting.
